BOOKING CONFIRMATION AND PAYMENT SCHEDULE Events will only be confirmed when a completed booking form and the 25% deposit have been paid within 48 hours of the booking form being shared. The full remaining balance of the minimum spend, hire fee and service charge are due 14 days prior. Should you wish to pay via EFT, you must request an invoice at least 21 days prior. Any preselected food and beverage requirements above the minimum spend can be prepaid or paid on the day. Additional costs incurred during your event must be paid in venue and will incur the 10% service charge.

MINIMUM SPENDS & OUTSTANDING BALANCES

In the instance the agreed minimum spend is not reached, the remaining amount will not be refunded, or transferred to a different area

CANCELLATION

We appreciate that circumstances may occur, which could make it necessary for a reservation to be cancelled. In all instance's written notice is required and the following cancellations fees apply:

- · Greater than 30 days notice The 25% deposit is withheld as a cancellation fee
- 29-15 days notice 50% of the agreed minimum spend and
